We may revise these Terms and Conditions at any time by updating this page. By registering for this Activity, you agree to be bound by any such changes.

By registering and/or participating in the “Nioxin Blogging Activity” (hereinafter referred to as “Activity”), you irrevocably agree to and assure the following:

1. This Activity is being organized and conducted by BlogAdda in association with Nioxin. This activity starts from 30th of April and closes 30 days after the event in each city. BlogAdda & Nioxin may in its discretion alter the Activity Period.

2. Registration:

Interested Participants must register for the Activity using the online registration form accessible via the link available on (<http://www.blogadda.com/nioxin-registration>)

3. Shortlisting

If you are shortlisted, you shall be informed by email at the email address provided by you in the participants application. You must respond to the notification within two (2) business days, and in case of any delay from your side, you shall no longer be admitted as a Participant and shall be replaced by other participants.
